How to plan ORGANIC & NATURAL COSMETICS certification fees and the principles of calculation

Total cost of certification is calculated based on:

Main service fees

1. Application Fees: 200€ fee for annual application of products, which includes annual logo usage permission.
2. Document review fee.
3. Physical and/or remote inspections fee.
4. Production certification fee.
5. Product certification fee.
6. Ingredient approval.

All additional charges for services are subject of adjustment in accordance with project size, complexity and requested services.

4. Export/trade Certificate fees.
5. Additional services.

Main Certification Services

Service title	Description	Price (in €)	Additional comments
Application	Application fee is paid annually to obtain or renew annual certification and includes ONC logo usage permission.	300 EUR / annual	Application fee is non-refundable. Application fee is paid even if no production is happening in current year, but the operator is willing to use ONC LOGO on products or advertisement materials.
Document review fee	Document review is applicable for documentation review and confirmation of further certification process. Fee is calculated on daily basis.	100 EUR per day	
Inspection fee	Inspection is applicable for physical inspection of production facilities and ingredient production. Fee is calculated on daily basis. Inspection day includes inspection at facilities, sampling (if needed) and inspection report.	300 EUR per day	Inspection fee does not contain inspector travel, accommodation and food costs during inspection. These costs will be agreed and presented after inspection.
Travel Time	Travel time is charged in addition to Inspection Fee, which refers to travel time of inspector to / from operation.	150 EUR per travel day	
Production Certification	This fee applies for production methods, general practices, facilities, sub-contracted activities, parallel production, records, ingredient certification, etc.	400 EUR per day	This fee does not include individual products.
Product Certification Fee	Certification fee depends on complexity of product composition and is based on quantity of ingredients in product	see table below	The certification fee will be calculated based on the complexity of the verified product. See the table below.

Ingredient approval	Refers to approval of agricultural non organic, agricultural in-conversion, non agricultural cosmetic ingredients and raw material.	20 EUR per ingredient	Applies to ONC producers and independent ingredient producers willing to approve ingredients. Annual Application fee and Document review fee for independent ingredient producers is applicable.

Export Certificates (Transaction Certificates)	Export certificates or Transaction certificates may be provided upon request.	50 EUR per certificate	Actual mailing expenses may apply.
Sampling fee	This charge will apply in case of need of sampling outside the routine inspection process. (lab analyses NOT included)	20 EUR per sample	Extra travel for sampling, banking, mailing, lab test and any other relevant expenses will be calculated on case by case basis. In case of subcontracted sampling, actual charges will apply.

Laboratory analyzes expenses	Laboratory analyzes expenses apply based on actual costs from subcontracted laboratory. Charges may include banking commission, tax charges, custom charges and mailing costs.	Case based	ECOGLOBE cooperates with ISO 17025 accredited laboratories.
Label Approval	Up to 5 final product labels approval per year is free of charge. Additional labels presented for approval will be charged accordingly.	10 EUR per label

Translation of certification documents	If any of certification documents (e.g. Inspection report, certification decision etc.) need to be translated, this charge will apply.	50-200 EUR, based on volume
